## Run Oxford Business Meeting Minutes July 9 2025

Meeting called to order by President Jurss.

Secretary Klingler documented the presence of the following members in good standing:

President Jurss presented the agenda. Treasurer Bunch moved to approve the agenda, and Secretary Klingler seconded. The agenda was approved unanimously by voice vote.

Treasurer Bunch gave the treasurer's report. The club's taxes still need filing for 2024, and costs \$300, which the club has yet to pay. We have \$106.66 left in our account, and we need to find funds to pay our taxes. Treasurer Bunch made a personal contribution of \$500 in March, and more money is still needed.

Secretary Klingler gave the membership report. There are 21 single or joint memberships in good standing, and eight single or joint memberships have been collected as part of the summer membership drive.

President Jurss initiated the discussion of club finances.

Nathan Hammer discussed the website, which at one point was hosted at the University, which cost only about \$15 per year. Nathan said that we eliminated a \$50 monthly fee for the website certificate, lowering the cost to approximately \$220 per year.

Treasurer Bunch said that our club insurance with RRCA, which is essential, costs approximately \$300 per year.

Treasurer Bunch said that our taxes cost approximately \$300 per year, and if we could find a club member who is a CPA to volunteer that would cover most of the tax expenses. President Jurss said that he would volunteer to review the tax forms.

Treasurer Bunch said that our expenses currently run to about \$1000 per year.

Treasurer Bunch turned the discussion to revenue, and raised the issue of possible underpayment from OPC for the I Can 5K program in January. The program is not a

money maker, and the former coordinator did not recieve compensation, so any future iterations should have a volinteer instructor. New officers should be clear that they should not expect to make money from their involvement.

Nathan Hammer stated that the cost of membership needs to go up. Jessica Interiano highlighted that a two person membership only costs \$5 more and this is low. Treasurer Bunch responded that this was implemented to allow people to add their kids as members, and Jessica responded that we should differentiate between spouses and children. Nathan said that if everyone paid \$50 per year with a shirt, or \$30 without one, we would be in a much sounder financial position.

Secretary Klingler said that he had been in communication with Ty Russell at Fleet Feet and there was a strong likelihood they would be able to sponsor our insurance for 2026.

Tyler Hunter suggested a membership incentive in which a bag tag carried large discounts to the holder, and beating the holder at a group run allowed the winner to take the tag. Tyler also suggested allowing guests to attend group runs 3 times before being required to become a member. Jessica responded that she became a mumber right after the run.

Adam Stewart suggested rebranding Run Oxford to RunOx, which was developed by a team of designers and marketing professionals. Adam presented designs for a RunOx t-shirt for which sales would generate \$10 for Run Oxford. Tyler suggested a series of limited run shirts.

Adam also suggested getting sponsorships from Campbell Clinic and Fleet Feet for the shirts, and said that it is realistic to up the membership price. Nathan said that we can get sponsors to pay for shirts.

President Jurss began the discussion of 2026 officers.

Secretary Klingler said that he would not be running for an officer position for 2026 as he was term limited out, and that President Jurss' term would also be up. In addition, Vice President Wronski desires to resign if others wish to be appointed to her position. As a result, there are at least three open officer slots for 2026.

Adam Stewart and Tyler Hunter indicated that they intend to run for officer positions for 2026. Secretary Klingler stated that Lexi Duscher and Ty Russell also have indicated desire to take on officer positions for 2026. Treasurer Bunch offered to run the books if Adam and Tyler will take responsibility for funding the club's needs as Treasurer Bunch and Nathan have repeatedly used personal funds to cover club revenue shortfalls.

President Jurss suggested having the next business meeting and Fall Social on October 8, 2025. After discussion the suggestion was unanimously approved by voice vote.

President Jurss raised adjournment. Nathan moved to adjourn, Secretary Klingler seconded, and the motion to adjourn was approved by voice vote.
